As you are well-aware, in the past months we have seen inflation soar. Gas prices and food prices have made it all the more difficult for those who are on fixed incomes to “make ends meet.” One Thursday in July an older, retired lady came in for help with her utility bill. She had gotten food earlier in the month but realized she needed to come for us for help with the latter. She came accompanied by her school-age granddaughter who she was keeping for a month this summer while her mother was deployed. The volunteer approached her to see what help she needed. With tears in her eyes, she said she had never had to do this before but she needed financial help with her utility bill. We reminded her that many are in a similar situation.....she is not alone. She continued, “Either I pay this bill and have no money for food or I buy food and have no money to pay this bill.” We let her know that that was the reason we were here. She said she had a bill for \$56 dollars. We told her we would pay that bill and informed her that she would not be eligible for help with utilities for another year. She was very thankful we would help now. We also let her pick out fresh vegetables and fruits, bagged Panera Breads, and some snacks for her granddaughter. While one volunteer was helping the grandmother, another volunteer was interacting with and entertaining the granddaughter who became fully engaged with her. She let her choose a little necklace and a small zipper purse and also shared a Bible story with her. Both grandmother and granddaughter left with smiles on their faces and happiness in their hearts.

In July we were presented with an exceptional gift donated by a couple in our church. It was a large framed picture of the head of Jesus Christ. Actually it was a 1000-piece puzzle they had assembled and then framed for us. It is absolutely beautiful and compelling! Feel free to stop by sometime when we are open to see it. What a great witness it will be to our families we serve (and us.) Genuine thanks to this couple for sharing their time and talents with us to witness to our Common Grounds family.

## **Morris UMC Endowment Fund**

On June 20, we had a special conference in reference to the endowment fund. The conference was well attended by members of the congregation, and there were a lot of great questions. For those who couldn't attend, this article is to explain what took place.

In the last several years people were tasked with overseeing the endowment fund, and they did a great job in growing the fund. They should be commended in how they were able to grow the fund that will benefit the church in many ways for years to come. We thank them for their diligent efforts and their accomplishment on behalf of the church.

In the UM Church the Trustees Committee is the responsible party for overseeing any endowment, however, our UMC Discipline states that it is permissible to establish a permanent endowment committee to work with the Trustees in the oversight of an endowment. This requires the action of a charge conference. Unfortunately, this was not done in the past, so a special charge conference was held to establish a permanent endowment committee. Here is the new language in the endowment guidelines regarding local oversight:

### **Local Oversight:**

The Board of Trustees of Morris Memorial United Methodist Church has entered into an agreement with Davenport & Company LLC for investment management of the fund with the provision that on recommendation of the Board of Trustees and approval of the Charge Conference said management may be changed.

The Board of Trustees shall provide local oversight of the fund through the establishment of a Permanent Endowment Fund Committee that will operate under the supervision of the Board of Trustees. This committee shall consist of the Board of Trustees President, the senior pastor, and three additional members from the local congregation. The Board of Trustees shall coordinate with the Committee on Nominations and Leadership Development to nominate the three additional members with final approval being determined by the Charge Conference. In accordance with The United Methodist Church Book of Discipline, the members of the Permanent Endowment Fund Committee shall not consist of relatives living within the same household or the current church Treasurer. The members shall be divided into three classes, each class consisting of one member, to serve a term of three years.

The Permanent Endowment Fund Committee shall maintain an appropriate public record of persons giving to the fund and/or the person memorialized by the gift, with information describing the association or previous service of such individual to the local church along with other facts of historical interest. The Permanent Endowment Fund Committee shall also maintain an appropriate record of transactions and fund statements and shall report the status of the fund to the Board of Trustees at least quarterly. Hard copies of all records and statements

associated with the fund shall be maintained at the local church office in a secure location. Any digital files used by the Permanent Endowment Fund Committee to maintain the fund shall be made accessible to the church Secretary upon request of the Board of Trustees President or senior pastor.

The amount of annual distribution available to be received from the fund shall be determined by the Permanent Endowment Fund Committee using the method described in these guidelines and shall be reported to the Board of Trustees. The Board of Trustees shall receive any distribution from the fund and direct its use as approved by the Administrative Board/Church Council. The Board of Trustees and the Permanent Endowment Fund Committee shall by promotional effort and publicity within the local church encourage giving to the fund through contributions and bequests.
